ADVISORY OPINION INTRA OSSEOUS CANNULATION

It is within the scope of practice of a Registered Nurse (RN) to place intraosseous devices if the following requirements are met:

I. GENERAL REQUIREMENTS

- A. A written policy and procedures are maintained by the agency/employer.
- B. Only RNs who have satisfactorily completed an instructional program and have had supervised practice are allowed to insert intraosseous devices.
- C. Documentation of satisfactory completion of an instructional program, supervised practice, and competency verification is on file with the employer.

II. COURSE OF INSTRUCTION is to include but not be limited to:

- A. Anatomy and physiology of the bone and circulation
- B. Indications and contraindications for the procedure
- C. Complications and management techniques to include potential adverse reactions
- D. Selection of appropriate site and preparation of site
- E. Technique of intraosseous device insertion and removal
- F. Nursing responsibilities

III. RATIONALE

The guiding principle for this opinion is that intra osseous cannulation insertion/removal can be safely performed by a registered nurse with specialized training, skills, and knowledge.
