

**FACILITIES SANCTIONED BY
ARIZONA DEPARTMENT OF HEALTH SERVICES**

A facility sanctioned by the Department of Health Services is ineligible to conduct or apply for approval of a nursing assistant training program for a period of two years from the date of sanction. The facility is also prohibited from serving as a clinical site in a nursing assistant training program offered by any other entity without a waiver granted by the Department of Health Services.
