Linck went over the 2006 NCSBN recommended key drug screening standards and CANDO/Monitoring recommended guidelines. Linck stated that 87% of those who relapse while in CANDO relapse within the first 18 months of the program. Smith stated that the overall relapse rate may be higher than other programs because the Board has a strict relapse interpretation. Smith detailed types of drug testing used and methods used by respondents to dilute or avoid submitting urine that would test positive. New technology is now in place to allow drug detection at a much lower threshold than in the past

Crawley moved, Malloch seconded, and after discussion it was unanimously carried to approve proposed policies: Positive Test Results on Body Fluids; Policy on Urine Screen Results with Low Specific Gravity and Low Creatinine; Failure to Test Body Fluids or Late Testing; and Relapse and Referral Back to Board.

## **I. Call to Order**

The meeting was called to order at 8:00 a.m., Friday, September 21, 2007.

The following Board members were present: Hardy, Crawley, Johnson, Link, and Malloch.

Hardy presided.

Hardy welcomed members of the audience and explained the procedure for addressing the Board.

## **VII. Board Reports for Discussion, Information, Staff Direction and/or Decision**

### **VII.A. Executive Director's Report**

#### **VII.A.3. Report on Commitment to Regulatory Excellence (CORE) – Arizona Data - Ridenour**

Randolph reported on the education portion of the CORE Report. Data was collected in 2005 under the direction of NCSBN. In the survey tool 12 nursing programs responded for a 24% return rate. Nurses thought their education prepared them “well” or “very well” 92% of the time. Arizona employers ranked new graduates at 2.11 on a 1-4 scale, which fell into the “somewhat adequate” category. New graduates were rated less than the aggregate average and ranked Arizona 20 out of the 24 states surveyed. The best ratings for new graduates were for administration of medications by common routes, performing psychomotor skills, recognizing abnormal findings, and responding to emergency situations. The lowest ratings were for documenting a legally defensible account of care, teaching patients, creating a plan of care for patients, assessing the effectiveness of treatment, recognizing abnormal diagnostic lab findings, and supervising care provided by others. Ninety three percent of nurses reported that there was content from the Nurse Practice Act in their program curriculum compared to an 87% aggregate rating. Seventeen percent of nurses surveyed reported they had attended a Board meeting. The perception of the Board functions by nursing programs rated the Board “very effective” in public protection, ranking 1 out of 23. Arizona ranked 6 out of 23 in promotion of quality in nursing programs. In the area of responsiveness to healthcare, responsiveness to healthcare changes, and responsiveness to innovations, Arizona ranked 8 out of 23. Effectiveness of the program review process was rated “effective” to “somewhat effective”, with high ratings for administration, clinical facilities, and curriculum. Slightly lower ratings were related to faculty and employment input into curriculum. Specific perceptions of the review process were measured on a 1 to 4 scale, 1 being the highest. Areas of strength include the comprehensiveness of the feedback, with Arizona ranking 1 out of 23, fairness in monitoring compliance and fairness in objectivity of Board findings ranking 8 out of 23. Lower scores were noted in the areas of time spent on site visits, and communication with Board staff. Nursing programs ranked the Board “somewhat helpful” in addressing emerging issues, “fair” in the sanction process, and “somewhat helpful” regarding educational issues and assistance provided by Board staff. Programs rated the Board as having “adequate” regulation and protection of the public, Scope of Practice, and practice standards. Ratings fell into the “too much regulation” category for the complaint resolution discipline process and education program approval. Programs consistently rated shortages of faculty in clinical sites as their biggest challenge, lack of competitive salaries and qualified faculty are equal as major reasons why positions were unfilled. Arizona falls well below the aggregate average for LPN clinical hours with high 200's to low 300's with the national average being 771 average hours. Associate degree clinical hours fell slightly above the aggregate average with 725 hours with aggregate average being 620. Randolph summarized by stating that the Board rated favorably in most categories as reported by the education programs that responded to the survey, with areas for improvement being communication with nursing programs, improving the site visit processes and responsiveness to emerging issues and changes in nursing practice. Randolph reported that a questionnaire would be offered at the upcoming statewide meeting to follow up on some of the issues and how the Board could improve.

**VII.A.9. Update on Nursing/Workplace Data Collected from RN/LPN Renewing in 2007 – Randolph/Ridenour**

Ridenour offered an update on Nursing/Workplace Data Collected. She reported that ASBN in partnership with ASU for information and research regarding work force needs. The tentative projection is that 4,000 RN’s will need to be added to the population each year over the next 10 years to keep up with workforce demand.

Busby arrived at the meeting at 8:21 a.m.

**VII.A.10. Proposed Conference Scheduled for Spring on Foreign Nurse Applicants & Emerging Issues – Bontrager/Randolph/Ridenour**

Randolph reported on a proposed conference scheduled on: License Issues for International Applicants. Plans are to invite Board approved credential evaluation agencies to speak to objectives relating to the process of evaluating credentials, types of reports offered by various agencies, and the issues for the credential service in determining comparability of education. Discussions will be held to explore the issues for regulatory Boards and invite Boards from other States to attend. Additional categories suggested were identifying best practices for insuring security of international licensure examinations, describing actions that a regulatory body should take when information is received that cheating or fraud occurred, and the types of visas acceptable for licensure purposes.

The Board members and staff dialogued with Boswell School of Nursing Students regarding Board functions, policies and procedures. Questions were asked on how fines are imposed.

Malloch left the meeting at 11:41 a.m. and returned at 11:43 a.m.

**VII. Board Reports for Discussion, Information, Staff Direction and/or Decision**

**VII.A. Executive Director’s Report**

**VII.A.3. Report on Commitment to Regulatory Excellence (CORE) – Arizona Data - Ridenour**

Ridenour stated that the CORE report is a compilation of Board’s of Nursing from 42 States which gives data to help understand if the public is being protected with evidence based regulation. Ridenour explained the range in budgets with 60% for investigations, 5% for education programs, and 10% for licensure, with other expenditures allocated for assistant attorney generals wages. Expenses per licensee (total budget divided by number of licensees) averaged \$33.42 with 26 Boards reporting, which placed

Arizona below the national average of \$37.91. The aggregate average for estimated time to resolve a case by licensee type national average, from 31 reporting Boards, was 9.31 months with Arizona's average at 7.3 months. Ridenour reported that Arizona was reported as one of the top 9 Boards overall. The average cases opened monthly for responding Boards were 829, with Arizona opening 758 cases. Arizona placed 32% below the aggregate average for individuals placed on probation. The aggregate average for nurses who violated Board orders in 2005 was 38, with Arizona at 71. The aggregate average for number of actions overturned or modified nationally was 1.1 and Arizona was 3. The aggregate average of formal settlements in 2005 was 79 and Arizona was 51. Number of days to verify a license was 8 and Arizona was 14. Bontrager stated that most recent data for licenses verified was 2.9 days. The aggregate average of Formal Board settlements was 15, with Arizona at 8. Ridenour reported that of the 28,000 nurses who were sent the survey, 5,000 nurses responded, with 180 nurses responding from Arizona. Fifty two point nine percent of nurses educated in Arizona continue to reside and work in Arizona. Thirty nine point five percent of nurses working in Arizona endorsed from other states. Foreign educated nurses endorsing into Arizona has doubled since 2002. Of the Arizona nurses responding, the average number of years licensed to practice was 7.5 years as opposed to 21.2 years from 2002. Eighty seven point six percent of Arizona licensed nurses are currently employed. Further data reported: the majority of nurses (71%) continue to be employed in hospitals, the content of the Nurse Practice Act was included in the curricula of the nursing program was 93%, percent attending a Board meeting was 16.7%, the rating for the telephone system was rated in the "fair to good" range, the website and journal rating improved from 2002, perception of nurses in communication with the Board on non-practice issues was rated "satisfied", effectiveness in protecting the public increased slightly. Understanding the Scope of Practice was close to the 2002 rating of "understanding to completely understanding", helpfulness of the Board rated "very helpful", 100% indicated Board responded in a timely manner, 85.5% reported the Nurse Practice Act as the main methods used to obtain practice information and 53.8% the website. Of methods used to obtain/renew license, 36.1% mail, 11.8% walk-in, 34.9% printed application from Board web site and mailed/faxed in, 13.6% on-line for entire process, 3.6% other. Ridenour stated that on-line renewals have increased dramatically since the survey information was gathered in 2002. Eighty seven percent of the nurses responding to the survey were involved in the disciplinary process by filing a complaint. In the future, when disciplinary processes are complete, a questionnaire will be mailed to respondents with response being sent directly to NCSBN with the hope that more individuals will comment on the process. Fairness of disciplinary process to all parties was improved to near "very fair", fairness of the investigative process was also near "very fair". Timeliness of the disciplinary process, 71.4% reported the complaint was resolved in a timely manner. Fairness of the resolution process was rated near "very fair", aspects of the disciplinary process was rated near "very well", effectiveness of the disciplinary process in protecting the public was rated near "very effective", 64% reported they know how to report a violation, understanding the obligation to report conduct which violates the State Nursing Statutes and Rules rated near "completely understand".

Ridenour reported of the 30 employers that responded to the survey, the majority (96.7%) were Chief Nursing Officers, which rated the website "good" to "excellent", telephone system "fair" to "good", newsletter "good" to "excellent"; inquiry made by respondent's office "satisfied" to "very satisfied"; presentation by Board representative "satisfied" to "very satisfied"; 80% reported the Board of Nursing to be the first to contact with practice questions; employers rating of the Board's effectiveness in protecting the public was "good" to "excellent".

Link commented that much of the information collected from the employers should be shared with the nursing programs. Ridenour stated that much of the CORE report are areas the Board could not be held accountable for and suggested that another type of survey would be more helpful in providing information pertaining to the Board. Malloch suggested if a Board retreat is planned for 2007, that some focus be placed on the CORE findings and key areas to make quality indicators. Ridenour stated that the next journal/newsletter would be devoted to the reporting of the CORE information. Ridenour commended staff and stated that the positive outcome of the CORE report is because of staff and their

effectiveness and competency. Tentative plans were made for a Board retreat in 2007 with actual dates to be decided.

Busby left the meeting at 12:02 p.m.

Ridenour reiterated the Board’s direction from the previous meeting that permission was given for staff to pursue potential funding from ACCHSS or ADHS. Ridenour stated that it would need to come from an appropriation from the general budget and not from the above mentioned agencies. Ridenour reported there is a significant budget revenue shortfall predicted and direction has been given to delay hiring and hold on any expenditure that can be held off till a later time.

**VII.A.8. Update on Investigative Cases, Hearing Department Data, Personnel Changes – Bontrager/Smith/Randolph/Ridenour**

Smith announced that Ridenour would be recognized at the upcoming first Joey Ridenour Nursing Excellence Award presented by the Maricopa Health Foundation. This annual award named in Ridenour’s honor will be given to recognize nursing excellence, with the first annual award being presented to her. Smith also announced that Ridenour will be inducted into the American Academy of Nursing. Smith introduced senior investigators Frank Curatola and Doug Parlin as the newest staff members. Smith gave a brief overview of the investigative case load and reported the investigative timeframe at 7 months with priority one cases less than 180 days.

Zack reported on the Hearing Department and stated there are 25 open cases from 2006, 62 cases open 2007 YTD, with a total of 88 open cases. There are 87 cases scheduled for hearing. Year to date, in addition to hearing cases, the Hearing Department handled 87 Motions to Deem resulting from Notice of Charges issued by consultants/investigators.

**VII.A.11. 2007 License Time Report – Compliance Report - Bontrager**

Information was provided to the Board regarding 2007 Licensure Timeframe Report.

**VII.A.18. Recommended Changes to Applications to Comply with House Bill 2467 & Federal Requirements Regarding Submission of Documents Demonstrating Lawful Presence in US – Bontrager/Ridenour**

Zack stated HB 2467 requires submission of documentation to demonstrate lawful presence, and states what will be needed to meet the requirement. Zack further stated there is no official position at this time, from the AAG, and advised the Board to hold off on implementing this law.

**VII.A.16. Program Summary Data – Ridenour/Bontrager/Smith/Orchard**

Ridenour offered an overview of the Program Summary data, submitted after the original budget is submitted.

**VII.E.1. Update on Motion to Deem Licensees & Certificate Holders - Zack**

Zack brought to the attention of the Board that statute 32-1664(i) wording needs to be changed if the Board's intent is different than what is stated in the statute, which states that a respondent "shall" give notice in writing if they request a hearing. Ridenour also provided information to the Board regarding the intent of the Board. The Board agreed that the letter of the law in the statute must be followed.

**VII.D.3. Update on Board Appointment & Scheduling of Board Meetings 2008 – Hardy/All**

Hardy stated there has been no word from the Governor's office regarding appointment of Board members.

**VII.D.1. 2007 NCSBN Delegate Assembly Report – Hardy/Crawley/Malloch**

Crawley gave a brief summary of one of the breakouts held at 2007 NCSBN Delegate Assembly.

**VII.D.2. NCSBN Board of Directors/Area I Director Report - Malloch**

Malloch gave an update as Area I Director and stated there is no national statement, guidelines, or principles from a regulatory prospective on how licensees can move back and forth between jurisdictions. Malloch reported on projected plans for strategic initiatives regarding disaster preparedness, guidelines, and a national nurse database for licensees during time of disaster.

**VII.D.4. Debriefing on Board Processes & Suggested Changes - All**

Malloch commented on the difficulty presented when large amounts of reading material are given to Board members at the Board meeting. After discussion Board members gave staff direction to craft a policy and bring back to the November 2007 meeting stating that submission of additional materials must be provided to Board staff no less than 10 days prior to the meeting. Malloch noted that talk between two Board members when the remainder of the Board were discussing and deliberating is

distracting and that it could give the appearance of being a side bar. Board members agreed that many comings and goings of some Board members during meetings is also distracting. Board members commended staff on the way speaker slips were handled at this meeting and asked that it continue to be handled in this manner. Malloch suggested ways to move the meeting along by asking for a motion sooner. Questions were raised as to why the 5 minute limit for respondents/attorneys/complainants was not used during Hearing cases. It was suggested that a verbal request to keep time to a limit would be helpful. Ridenour stated that it wasn't necessary to read the licensee/certificate holder's # into the record when opening a case. Malloch commented on how many Board members are in and out of the meeting multiple times during the 3 days of meeting time. Members agreed that some things do come up that make it necessary to leave.

#### **VIII. Call to the Public**

**A public body may make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the public body. The Board may ask staff to review a matter or may ask that a matter be put on a future agenda. Members of the public body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action. A.R.S. § 38-431.01(G).**

Link moved, Malloch seconded, and it was unanimously carried to adjourn the meeting.
