Jane Werth, Director of Community Partnership Programs, Maricopa Community Colleges, was present and offered an overview of the surveys performed at the direction of the Education Committee. In September 2008, the survey sought to quantify and objectively measure the clinical placement environment in the state and obtain the clinical site coordinators perception. Committee members were concerned with reports from programs stating that clinical placements were increasingly unavailable and not suitable for meeting program outcomes. Board staff also noted that students frequently report that their clinical group was cancelled at one location necessitating travel to a remote location for clinical. With some rural programs the travel may involve hundreds of miles and an overnight stay. Students experience additional stress when these abrupt changes occur. Finally the Board continues to receive applications from entities seeking to establish a new nursing program in Arizona. When informed about the challenges in securing clinical sites, the applying programs tend to minimize the issues and state they will use "non-traditional sites" or alternative hours. Once they are approved however, they are reported to compete for the same traditional sites and hours as existing programs.

Information was also provided to the Board about the January 2009 a survey, sent to Coordinators from Clinical sites throughout Arizona. The purpose of the survey was to obtain the clinical site coordinators perception.

**VII.A. Executive Director's Report**

**VII.A.6. Update from Greg Harris on Legislative Issues Impacting Nursing Regulation; Amendments to Senate Bill 1105 & Board Direction on Requested Changes to the Nurse Practice Act – Harris/Ridenour/Zack**

Greg Harris was present and offered an update on Legislative issues impacting nursing regulation, and amendments to the Senate Bill 1105. Harris also updated the Board on progress being made on the requested changes to the Nurse Practice Act.

**Recommended Substantive Policy Statement: A.R.S.§ 32-1631 Exemption Provision for Christian Science Nurse – Ridenour**

Harris stated there had been a call from Senator Allen's office requesting Executive Director Ridenour to have a conversation with a representative of the Christian Science Church who voiced concern about

the use of the “nurse” title by Christian Science nurses. Harris stated there was a discussion about the issue, which included the existing exemption in 32-1631(6), the religious practice exemption. Harris further stated that the Board’s perspective was that 32-1631(6) covered the concern. Not only does the statute exempt people who are engaged in religious service as a whole, the act includes the title protection so their use of “nurse” in connection with Christian Science, would also be exempted from the requirements of the act.

Busby moved, Johnson seconded, and it was unanimously carried to approve recommended substantive Policy Statement: A.R.S. § 32-1631 exemption provision for Christian Science nurse.

**VII.A.8. Update on Statewide Budget Deficit & AzBN FY 2009/2010 Budgets – Orchard/Bontrager/Ridenour  
Update on Discussion with JLBC Regarding Potential Legislation Specific to A.R.S. § 32-1642 Licensure Renewal Date Changed from July to April Every Four Years & Increasing the Fee Ceilings – Orchard/Bontrager/Harris/Ridenour**

Ridenour stated that Joint Legislative Budget Committee (JLBC) was potentially working on language relating to proposed changes in RN/LPN licensure renewal dates from June to April. This change is needed to provide the cash flow necessary for the Board’s budget. JLBC also offered to include increased ceiling fees in the bill, if there is a bill. Ridenour noted that nothing makes the nursing community more uncomfortable than changing the ceilings, even when it is a decision driven by the budget.

Orchard offered an update on the budget and stated she had received a phone call from JLBC (Joint Legislative Budget Committee) last week inquiring about some of the legislation that the Board is wishing to pass. Specifically, they wished to know which bills were important to the Board and how they related to the functions of the Board, its operations, the budget. Orchard explained that by changing the RN/LPN renewal date would help with the cash flow issues that arise each year during the renewal period in June. By moving the renewal forward to April, this would relieve those cash flow issues and would be a benefit and relief. Orchard further stated that, in the discussion, JLBC also wanted to know about the changes to the ceiling limitations and if this matter was something that was still important to the Board. She went on to say that she explained to JLBC that from a business standpoint, it is a good management decision to do so, for the future years. Orchard continued by saying that it is generally every ten years that the Board has needed to raise the fee ceilings, as it is currently, ten years since the Board last raised the ceiling limits. She also stated that the acceptance of grant funding was also discussed and informed JLBC that there were some statute changes in legislation that would give the agency the ability to accept grant money. Orchard informed them that, currently, there was some refinement of the bill’s wording taking place and that she would provide the JLBC the information as it came forward.

Ridenour concluded by stating that the information we know today may or may not change and that at this time, it is hard to know what to ask the Board to do. Ridenour requested the Board, if concerned, to voice any objections to the direction currently being taken with the budget.

**VII.A.7. Update on 2009 Legislation Related to Abortions & Impact on Nursing Regulation – Harris/Ridenour**

Ridenour stated that House Bill 2564 includes that only physicians can do abortions. Harris stated that House Bill 2564 and House Bill 2400 are 2 of only 7 bills that have cleared the House this year. Harris projected that if there were that few bills that were going to pass this year, these two would be among the few that would pass and signed into law. The question was raised as to the rationale for having only physicians do the abortions. Link indicated that it is being seen as a public safety issue. Link stated that she did not see it as a safety issue if it were performed by an advanced practice RN who had been educated/and had demonstrated competency to perform the procedure. Concern was voiced that the

decision may not be made on evidence based research. Link stated there had been discussion at the Adv. Practice Committee, with unanimous agreement by the committee to prepare an Advisory Opinion for the Board. The Board voted at the May, 2008, meeting that it was not outside the scope of an Advanced Practice RN. Others did not recall that the Board had specifically directed staff to prepare an Advisory Opinion, as a result of the Board vote, but rather to wait on the decision that would be made by the legislature. The Board agreed to bring this topic back to the June 2009 Board meeting for further discussion.

Robertson left the meeting at 5:00 p.m.

**VIII. Call to the Public**

A public body may make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the public body. The Board may ask staff to review a matter or may ask that a matter be put on a future agenda. Members of the public body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action. A.R.S. § 38-431.01(G).
