President Quinn reported on 1336, which was just introduced, which will expand the scope of practice for CRNAs, and clarifies what the word “direction” means. The surgeon does not direct the practice, and is not liable for the CRNA’s actions.

Executive Director Ridenour discussed 1072, which is sponsored by the Goldwater Institute, and it would require the Superior Court to decide on questions about the Board’s Findings of Fact and Conclusions of Law, instead of remanding it back to the Board.

Other bills discussed were HB 2271, which has to do with veterans being licensed without necessarily meeting licensure requirements, and B2135, which would be a committee study about what workforce demands will be in the future. This bill could cause the Board to be required to add a surcharge to our licensing fees to pay for it.

Joey Ridenour discussed possible reintroduction of legislation to expand the scope of the Board’s confidential monitoring program. The previous bill related to putting Letters of Concern on our website does not seem to be likely to be brought up again.
