RE: CEASE AND DESIST LETTER

Dear NUVEA MITCHELL:

The Board of Nursing has received information that you have been representing yourself as a nurse. There is no evidence that you have completed a Board approved nursing education program in the state of Arizona or any other state. Additionally, the Board of Nursing has no evidence or information supporting that you have ever been licensed in any state and the Delaware license presented belongs to a different unrelated individual.

Pursuant to A.R.S. § 32-1666(A)(1)(2): It is unlawful for a person who is not licensed or certified under this chapter to: (1) Practice or offer to practice professional or practical nursing in this state. (2) Represent or use any title, abbreviation, letters, figures, sign, card or device to indicate that the person or any other person is a registered, graduate or professional nurse.

Pursuant to A.R.S. § 32-1636: Only a person who holds a valid and current license to practice professional nursing in this state or in a party state pursuant to section 32-1668 may use the title "nurse", "registered nurse", "graduate nurse" or "professional nurse" or the abbreviation "R.N."

Pursuant to A.R.S. § 32-1606 (A) (4) The Board may refer criminal violations of this chapter to the appropriate law enforcement agency.

Pursuant to A.R.S. § 32-1667(2): A person is guilty of a class 6 felony who: (2) Engages in any conduct prohibited in section 32-1666.

The Arizona Board of Nursing demands that you immediately cease and desist implying to the public of Arizona that you are a nurse (RN).

Be advised that the Board, will forward your case to the Office of the Attorney General for review for potential criminal charges.
